

**A Resolution of the Council for the Borough of Courtdale to Fill a Vacancy in the Office of Mayor Pursuant to Section 901 of the Borough Code**

**WHEREAS**, a vacancy exists in the Office of Mayor of Courtdale Borough, Luzerne County, Pennsylvania, by virtue of the passing of Dorothy Duesler who was elected in November 2021 with a term commencing January 3, 2022, and concluding January 5, 2026; and

**WHEREAS**, pursuant to the Borough Code, under the scenario set forth above, the Members of Council, or the majority members thereof, are authorized to fill such vacancy until the first Monday in January after the first municipal election occurring more than sixty (60) days after the vacancy occurs. In this instance, the mayor appointed herein shall serve until January 2, 2024.

**NOW, THEREFORE, BE IT RESOLVED**, as follows:

1. The recitations above set forth are incorporated in this Resolution as if fully set forth and adopted herein.

2. Pursuant to Section 901 of the Borough Code Jaclyn Degnan, a qualified resident of the Borough of Courtdale is hereby appointed to fill the vacancy existing in the Office of Mayor of the Borough of Courtdale. This appointment is effective upon said person taking the oath and providing the required affidavit pursuant to Section 801(a), and the said Jaclyn Degnan, shall hold office until January 2, 2024.
