A RESOLUTION OF THE BOROUGH OF COURTDALE AUTHORIZING THE SUBMISSION OF A 2022 MULTIMODAL TRANSPORTATION FUND GRANT REQUEST, DESIGNATING BOROUGH OFFICIALS TO EXECUTE DOCUMENTS AND ASSIST IN CONNECTION WITH OBTAINING THE REQUESTED GRANT

WHEREAS, the Borough Council of Courtdale has determined that it is in the best interests of Courtdale Borough to request a grant under the Pennsylvania Department of Community and Economic Development Multimodal Transportation Fund for financial assistance for the purpose of repaving numerous streets in the Borough; and

WHEREAS, the streets for which the Borough is seeking funding have not been paved or repaired in decades and are in a state of severe disrepair; and

WHEREAS, in accordance with the MTF Grant Program requirements, the Council declares by this resolution its approval of the grant request and designates Borough officials to be authorized to execute documents and agreements and assist in applying for and obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED:

THAT, Council for the Borough of Courtdale authorizes the formal request for funding in the amount of **Two Million Three Hundred Eleven Thousand 400 Hundred Dollars (\$2,311,400.00)** for the purpose of paving numerous streets within the Borough of Courtdale; and

THAT, Council Chairman, Carl Hodorowski, Councilman Thomas Vest and Borough Secretary Jill Dietrick shall be the authorized signatories for all documents related hereto; and

THAT, if any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be unconstitutional or otherwise illegal or unenforceable, such decision shall not affect the validity of the remaining portions of this Resolution; and

THAT, the instant Resolution was passed at the advertised regular meeting of the Borough of Courtdale; and

THAT, this Resolution shall be effective immediately upon passage.

BE IT RESOLVED AND IT IS HEREBY RESOLVED THIS 19th day of JULY, 2022, by the Council of the Borough of Courtdale.


