

**A RESOLUTION OF THE BOROUGH OF COURTDALE AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR A LUZERNE COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) APPLICATION AND DESIGNATING BOROUGH OFFICIALS TO EXECUTE DOCUMENTS**

**WHEREAS**, the Borough of Courtdale is in need of funds for specific purposes authorized under the Luzerne County CDBG Block Grant Program for the purpose of repaving numerous streets in the Borough; and

**WHEREAS**, the streets for which the Borough is seeking funding have not been paved or repaired in decades and are in a state of severe disrepair; and

**WHEREAS**, a Resolution is required to authorize, apply for and receive the Grant; and

**WHEREAS**, it is the desire and intent of the Council for the Borough of Courtdale to pass the instant Resolution to authorize, make application for, set an amount, provide a description of scope and designate signatories thereto.

**NOW, THEREFORE, BE IT RESOLVED:**

**THAT**, Council for the Borough of Courtdale authorizes the formal request for funding in the amount of Six Hundred Ninety Three Thousand Two Hundred Dollars (\$693,200.00) for the 2025 Courtdale Borough Street Paving Project as more fully described by the Borough Engineer in the narrative attached hereto, made a part hereof and labeled Exhibit "A";

**THAT**, Council President, Carl Hodorowski and Borough Secretary, Loriann Monto shall be the authorized signatories for the Borough for all documents related hereto;

**THAT**, the instant Resolution was passed at the advertised regular meeting of the Borough of Courtdale; and

**THAT**, this Resolution shall be effective immediately upon passage.
