A RESOLUTION OF THE BOROUGH OF COURTDALE APPROVING A USER FEE OF \$50.00 PAYABLE TO THE BOROUGH OF COURTDALE PURSUANT TO 42 PA C.S.A. §1725.3

WHEREAS, Pennsylvania Act 142 of 2016 also known as the Officer Brian Steven Gregg Law (the "Act") authorizes paramedics to provide assistance to law enforcement agencies upon request to perform legal blood draws on behalf of the law enforcement agency from persons suspected of violating certain criminal statutes as set forth therein; and

WHEREAS, under the circumstances set forth above, Courtdale Police Officers will have certain responsibilities and duties regarding the administration and chain of custody of the blood draw; and

WHEREAS, the Act authorizes the imposition of certain fees by law enforcement agencies who provide services in the prosecution.

NOW, THEREFORE, BE IT RESOLVED:

THAT, the Council for the Borough of Courtdale authorizes the imposition of a user fee in the amount of fifty dollars (\$50.00) payable to the Borough of Courtdale pursuant to the Act; and

THAT, if any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be unconstitutional or otherwise illegal or unenforceable, such decision shall not affect the validity of the remaining portions of this Resolution; and

THAT, the instant Resolution was passed at the advertised regular meeting of the Borough of Courtdale; and

THAT, this Resolution shall be effective immediately upon passage.
